

Medical Termination Of Pregnancy ACT-1971



Guardian – The person having the care of minor.



Register Medical Practitioner – The person a medical portioner who possess any recognize medical qualification as defined in clause H of section 2 of Indian medical council at 1956



Owner – owner un relation to place means any person who is admirative head o otherwise responsive for the work or maintaining hospital and clinic



Place- It is a building tent vehicle or vessel or part there of use for establishment or maintained of a hospital



Circumstance

Pregnancy is not more than 12 weeks



a) Serious injury to physical or mental Health of women.

b) Child to be born would be serious Handicapped due to Physical or Mental abnormalities.

2. More than 12 weeks but less than 20 weeks.

3. RMI may terminate pregnancy of a women 18 years of age.

4. RMI may terminate pregnancy of a women less than 18 years of age.

Experience or Training

-The MTP Rules 1975 prescribe the experience in Gynecology,

a) A medical practitioner register in state, should not less than three years' experience in gynecologist.

b) A medical practitioner registered in a state, after the date → can terminate the pregnancy

I) complete six months of house surgery in gynecology

OR,

II) Hospital for a period not less than 1 year

OR,

III) 25 cases of MTP in hospital maintained.

c) Register medical practitioner, holds a post graduate Degree or diploma in gynecology



Place approved for Treatment of pregnancies

- a) Government satisfied the termination of pregnancy done they're under safe and hygienic condition
- b) facilities are provided-
 - i) Operation table and instrument for abdominal surgery
 - ii) Anesthetic equation, resuscitation equation and sterilization equation
 - iii) Drugs and parenteral fluids for emergency use.



Maintenance of admission register

Medical termination of pregnancy regulation 1975,

- i) Head of the hospital of the approved place should maintain register in prescribed form of the admission of women for termination of their pregnancies
- ii) Serial no should be given to each entry in their register
- iii) Fresh serial no. needs to be given in each calendar year eg.7/1987
- iv) Serial no of each year should be distinguishable
- v) Information should not be disclosed.



Offences



- 1) Termination of pregnancy by a person who is not RMP.
- 2) Any person who willfully contravenes or fail comply with the req. of any regulation made by state government.
